INSTRUCTIONS FOR SURVEYORS

RECORDS OF SURVEY

ref. AS 34.65.030

WHEN A RECORD OF SURVEY IS REQUIRED

After making a survey in conformity with the practice and definition of land surveying, a land surveyor shall file with the District Recorder a record of the survey within 90 days if the survey discloses:

- (1) Material evidence of physical change that in whole or in part does not appear on a plat of record previously filed in the office of the District Recorder or in the records of the Bureau of Land Management;
- (2) A material discrepancy with a plat of record previously filed in the office of the District Recorder or in the records of the Bureau of Land Management; or
- (3) Evidence that by reasonable analysis might result in alternate positions of boundaries from those of record.

Submittals

All Records of Survey filed in a District Recording Office must conform to the following basic standards:

- (1) Be legibly drawn in black ink on mylar or on diazo positive mylar sheets that do not exceed 32" x 36". Drawing must be capable of being legibly reproduced by a machine or device used in the recording office.
- (2) Show original and reestablished monuments and all distances and directions required to determine the location of all monuments established during the survey.
- (3) Notations describing survey procedures used to establish monumentation during the survey.
- (4) A. Drawing must include a statement specifically identifying the legal document that the survey is based upon. This statement must incorporate the filing number or recording book and page if documents are of record in the District Recording Office of this state.
B. If the survey is within an area governed by a platting authority, the drawing must state that "This survey does not constitute a subdivision as defined by AS 40.15.190(2)." Filing of a Record of Survey does not relieve the surveyor of the responsibility to comply with requirements of local platting authorities established under AS 29.33 and AS 40.15.075. A Record of Survey may not be used to facilitate the dedication of land for public purposes. Dedications require acceptance through the legal platting process.

Example: This is a deed of record Dounaary survey of the Deed Recorded in Book 00 at Page 000 in the _____ Recording District and does not constitute a subdivision as defined by AS 40.15.190(2),

- (5) Be sealed, signed and dated by tne land surveyor in charge of tne work. Must contain original signature.**
- (6) Contain tne title "RECORD OF SURVEY" and the (subdivision name if witrin an existing subdivision) Section, Township, Range and Meridian.**
- (7) Contain tne name of the Recording District into wnich is is to oe entered into the public record.**
- (8) Be accompanied by tne fee for filing, as set out in 11 AAC 05.010.**

It is the responsibility of the land surveyor to ensure that the prerequisites for filing documents as established by 11 AAC 06.050 and by statute are met.

WHEN A RECORD OF SURVEY IS NOT REQUIRED

A record of survey is not required for a survey

- (1) made by the Bureau of Land Manegenent;**
- (2) wnen a plat of survey has been filed or will be filed witrin 18 months after the field survey is completed.**

RECORDS OF MNUMENT

ret. AS 34.65.040

A land surveyor wno in tne course of a survey establishes, reestablishes, uses as control, or restores a monnument to make it readily identifiable or reasonably durable Shall file a monnument record, unless the monnument and its accessories are substantially as described in a monnument record filed under AS 34.65 or on a survey plat of record. Monnument records snall be filed on a standard Land Survey Monnument Record form provided by the State of Alaska, Department of Natural Resources.

An agency wnose activities will disturb or destroy a monnument or its accessories shall nave a land surveyor:

- (1) file a monnument record before tne monnument or its accessories are disturbed or destroyed;**
- (2) restore or replace tne monnument and its accessories after the activities have ceased; and**
- (3) file a new monnument record after restoring or replacing tne monnument or its accessories.**

A person who disturbs or destroys a monnument Snall file a notice of the disturbance or destruction in the office of the District Recorder. This notice will be filed on a Land Survey Monnument Record form however, in this circumstance the form may be filed by any person and does not require a

registered surveyor's seal. In note 1 of the form add the explanation: "Notice of disturbance." This does not relieve an agency of legal responsibility as previously stated.

A land surveyor may file a monument record for any monument.

A land surveyor who is required to file a monument record under AS 34.65 shall do so within 90 days of the completion of the survey or of the establishment, reestablishment, or rehabilitation of a monument.

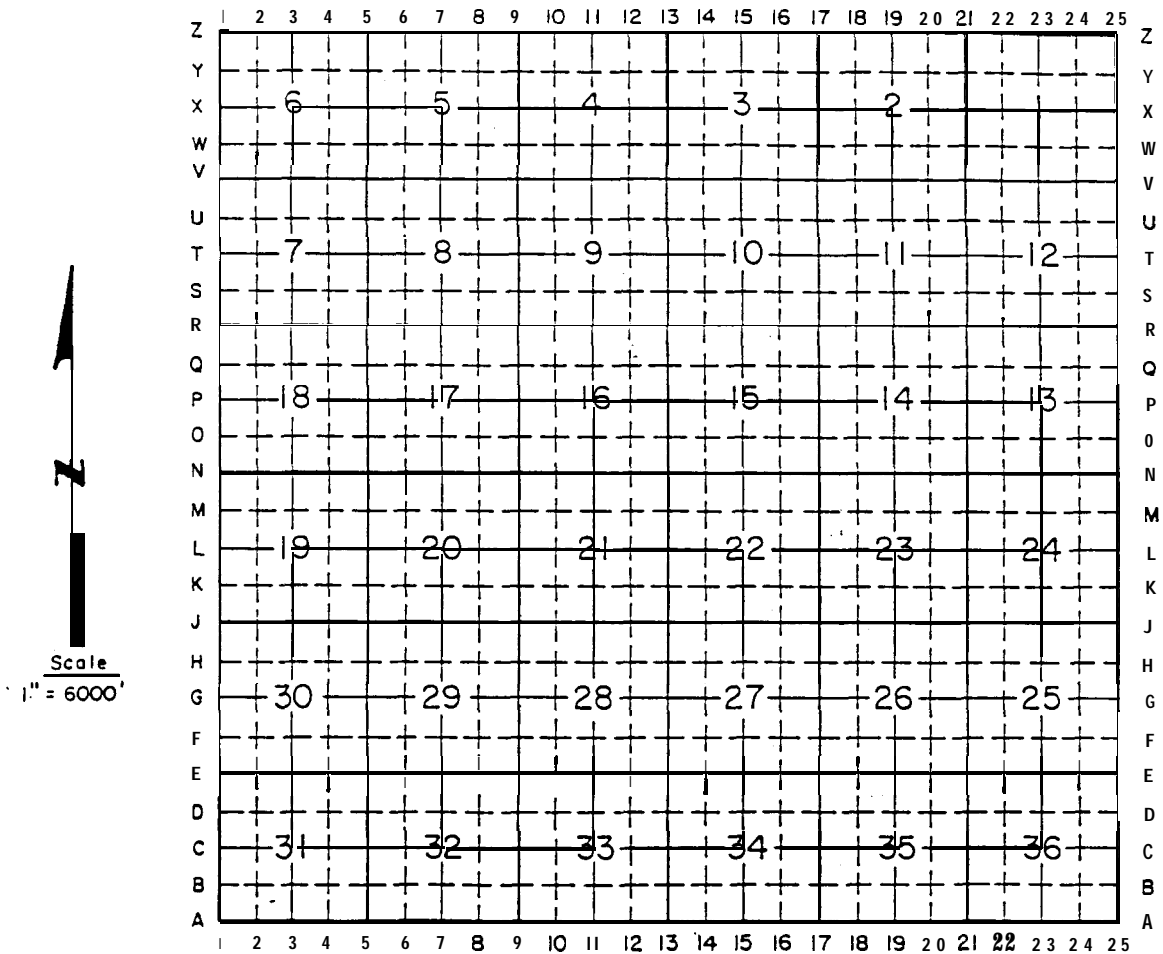
A monument record shall be signed and sealed by the land surveyor responsible for the survey.

Instructions for monument record forms

- (1) Report one monument only on each monument record form
- (2) List all pertinent evidence found (both physical and record) which was used to substantiate the position of the corner or explain, in detail, the evidence found and the survey procedures used to reestablish a missing corner. Include testimony of interested landowners, land surveyors or other qualified authorities or witnesses.
- (3) Describe the type of monument set or any restoration of the original monument. List all existing or established monument accessories which perpetuate the location of the corner.
- (4) Make a neat sketch showing the relative positions of the monument and reference points. Give dimensions with appropriate degree of precision; include north arrow and state oasis of bearings if used.
- (5) Prepare a sketch showing how the position for the monument being established was determined. Give the recording information if the monument is at a corner of a deed of record. If additional sheets are necessary, the Recording District information must be shown on the last sheet.
- (6) Fill in the surveyor's name, registration number, date, seal and signature.
- (7) Description of the corner. In addition to section, township, range and meridian, if the corner was originally shown on a subdivision plat, fill in the subdivision name and the plat filing information. Fill in "N/A" in subdivision name if not applicable.
- (8) Recording District information to be filled in by the Recorder's Office.
- (9) Show location of monument and the index number. See Alaska Land Survey Monument Master Index.

EXPLANATION

Each monument record is identified by a numerical-alphabetical index reference number which is related to the township diagram. For example, the quarter corner common to Sections 4 and 5 would have the index number 9-X.

Monuments which are not located at intersecting lines on the diagram are identified by reference to the southeast corner of the rectangle in which the monument is located. For example, if the location of a monument places it between numbers 4 and 5 and between letters J and K the index number would be S-J.

A monument which is common to adjoining townships will be identified by the index reference number in the township in which the record is to be filed, except in the case where a Recording District boundary coincides with a township line, in which case an appropriate index number shall be used for each Recording District involved.

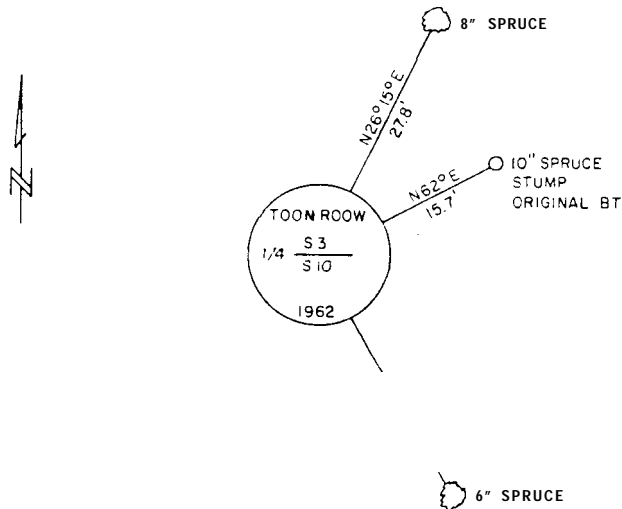
Found original BLM 3 1/2" brass cap on 2 1/2" dia. I.P. extending 1 5/8' above ground and **leaning to the southeast**. Found rotting stump of 10" spruce with the scribe marks " 3 BT " clearly visible on the side facing the monument at N62°E, 15.7'. BLM record is "A spruce, 10 ins. diam., bears N.60°15'E., 24 lks. (15.8') dist., mkd. 1/4 S 3 BT."

3. **DESCRIPTION OF MONUMENT AND ACCESSORIES ESTABLISHED TO PERPETUATE THE LOCATION OF THE MONUMENT**

Plumbed monument on its base and reset flush with ground and placed a 2"x4" red and white witness post 1' south.

Two new bearing trees were blazed flagged with orange plastic ribbon and a 16d nail was driven 3' above the ground in the right side of the tree facing from the monument (see sketch below)

According to Mr. John Jones, WHO OWNS and has lived on the property northeast of the corner for past 12 years, the monument and both original bearing trees were destroyed during construction of George Road. The corner was reestablished at mid-point between the N.E. corner of section 10 and the NW corner of Section 10 was adjusted south to secure the latitudinal curve.

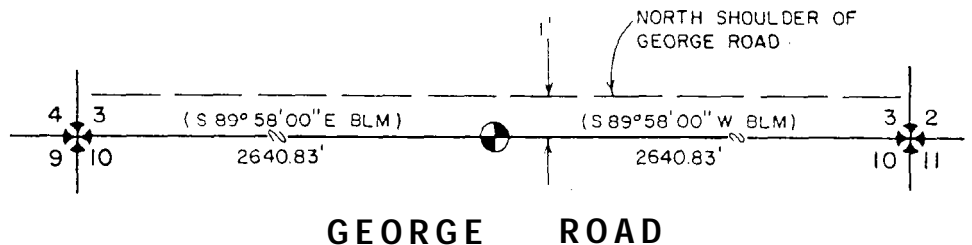
